

The BRIT Awards 2016 with MasterCard – Customer Promotion Terms & Conditions

1. The prize draw for a pair of level one tickets to The BRIT Awards 2016 with MasterCard (the “Promotion”) is promoted by Access Prepaid Worldwide Ltd (the “Promoter”). Registered Office: Access House, Cygnet Road, Peterborough PE7 8FJ, registered in England under number 05429739.
 2. The Promotion is open to all UK residents aged 18 or over, except employees of Travelex, the Promoter, their immediate family members, or any anyone directly connected with the planning or administration of the prize draw.
 3. By taking part in the Promotion, you agree to be bound by these terms and conditions.
 4. There are five (5) pairs of level one tickets to be won. You will be automatically entered into this Promotion to win one (1) pair of level one tickets to The BRIT Awards 2016 on the 24 February 2016 when you purchase and load a new Multi-currency Cash Passport™ (“Cash Passport”) from an in store Tesco Travel Money Bureau or reload an existing Cash Passport in store, with a minimum of £250 between 11 January, 2016 and 8 February 2016 (“Promotion Period”)*. Only one entry will qualify regardless of the number of (re)loads undertaken during the Promotion Period.
 5. The winners will be chosen at random on 9 February 2016 by an independent adjudicator.
 6. The winners will be notified within one (1) calendar day from the date the winner is chosen via telephone or by email.
 7. The winners will have two (2) calendar days from receipt of the winning notification to:

 - ii. Provide a valid ID in the form of a passport or driver’s license and proof they have an active Cash Passport™; and
 - iii. Confirm they wish to accept the prize.
